#### 11. RESOLUTION AUTHORIZING CLOSURE OF ENTERPRISE FUND

- 11.1. Mr. Weaver gave a quick recap of what an enterprise is and the history of when and how the Vail Recreation District started the fund. He shared that we had made our final bond payment and therefore there is no longer a need to have the Enterprise Fund.
- 11.2. After some discussion and hearing no public comment and by motion duly made and seconded it was unanimously RESOLVED to close the Enterprise Fund.

#### 12. RATIFICATION OF COST SHARING AGREEMENT WITH THE TOWN OF VAIL-GREENS RENOVATION

- 12.1 Mr. Ortiz shared that the Town of Vail agreement sharing in the cost of the renovation of the greens has been approved by Town Council. He is asking for the board to ratify the agreement for an annual amount of \$216 thousand per year with a project cap of \$650 thousand. After little discussion, the board agreed to ratify this agreement.

#### 13. STAFF ANALYSIS AND RECOMMENDATION ON LEASE PROPOSAL FOR FORMAL ARIA CLUB AND SPA

- 13.1. Mr. Ortiz shared that there was a meeting with several Town of Vail staff to discuss all aspects of the possibility of entering a lease for this space. With the help of Mr. Weaver and Mr. Timm they were able to put together a budget of what the financials would look like if we were to operate the club. After much discussion it was concluded that even with the help of the Town of Vail it was not financially feasible to take this on at this time.

#### 14. JANUARY 2021 FINANCIALS

- 14.1. Mr. Weaver explained that closing out the Enterprise Fund will now leave zeros on the balance sheet, those numbers have all been moved to the General Fund. He shared that we are early in the year and so far, both Gymnastics and Community Programming are showing budget savings. He also acknowledged how well Nordic continues to do and that overall, everything is looking good.

#### 15. EXECUTIVE DIRECTOR INPUT

- 15.1. Mr. Ortiz expressed how grateful he is for Jessie Klehfoth for all her hard work on making sure everything will be in place when she will take her maternity leave. He also acknowledged all her hard work on the organization and set up of helping the District find a new registration system.

**SUMMARY OF SIGNIFICANT VARIANCES:**

SPORTS REVENUES- Facility rental, whitewater, bike & running races, and camp registrations all seeing high demand and early registrations.  
 COMMUNITY PROGRAMMING REV- \$18,000 in unbudgeted grants helping to offset impacts due to COVID  
 NORDIC REVENUES- Truly an amazing 2020/2021 season with incredible increases in participation  
 GOLF REVENUES- High demand for early season pass sales.  
 DOBSON REVENUES- Hockey revenue not realized in January will hopefully be partially made up later in the season. TBD on what events may end up being able to be held.  
 GYMNASTICS EXPENSES- Savings in wages and benefits until new full-time employee started.  
 NORDIC EXPENSES- Overages in equipment maintenance and credit card fees from higher revenues.  
 DOBSON EXPENSES- Savings in Adult hockey with program postponed, events not held, as well as other areas.  
 GOLF BANQUET/ F&B EXPENSES- Savings in labor, cost of goods, and other areas with Gore Range Room revenues expected to be down significantly.  
 CAPITAL- Mostly timing on projects still planned to be completed later in the year.  
 CONTINGENCY- Increased from \$200K to \$300K for additional unknowns due to COVID19, but not needed as both revenues and expenses were favorable to forecast.  
 FUND BALANCE- Savings at end of 2020 rolled forward to 2021.

## VAIL RECREATION DISTRICT DIRECTOR REPORTS

May 27, 2021

### MARKETING

- The summer all-VRD brochure is now available in welcome centers and hotels around town. It is a great resource for locals and visitors to Vail.
- Marketing has also been hard at work on helping the facilities get ready for a busy summer! We have been working on golf and tennis rack cards, golf rate slides, tennis signage, banquet and restaurant menus for Grill on the Gore, gymnastics meet posters and much more.
- Now that VRD summer racing season is in full gear, marketing is staying busy with two email releases per event (press release and racer details), ads, social media posts, posters, photos, maps, website updates and more. Nell creates a custom t-shirt design for each of the trail running races. We have also been helping sports with their new Minturn Downriver Dash whitewater event with a logo, poster, social media posts and more.
- Our summer marketing assistant Bobby Cornwell has been hard at work! He has been taking amazing photos at all the races which go up on our social media platforms. He has also been creating fun Instagram stories. We have a goal to create more video content this summer, so he has made a video for gymnastics and is creating a series of "golf tips" videos for the Vail Golf Club – more video plans are in the works!
- We continue all daily and weekly forms of advertising including Vail Daily ads, radio ads, email newsletters, press releases and social media promotions. We have been rotating through all the different departments, highlighting all the great spring programming going on over the past month.
- The new Vail Recreation District website is up and running! It is working great, and we are continuing to improve and add to the site.
- With the Eagle County public health orders receding, Nell has been working with Mike and the Town of Vail to figure out our new protocols and any remaining mask requirements. New signage will be going up at all the facilities and the VRD website will be updated with our new protocols.

### GOLF

- Golf Course opens May 21<sup>st</sup>. We have eight temporary greens. We are offering a discount for green fees and cart fees. Normally a green fee is \$74 at this time of year. Currently we are charging \$25 to walk either 9 or 18 holes and \$42 to ride either 9 or 18 holes.
- We are fully staffed in golf operations for the summer through mid-August. We will need to hire additional staff when the young folks go back to school.
- Season Pass sales have been steady. We shall see how pass sales go into June with the course healing from the winter.
- The driving range has been steady since we opened on May 14<sup>th</sup>. The set up on the range is back to our "normal" set up with full hitting stations and ball machine. We are not doing reservations this year.
- We continue to plan for summer and continue to book several small groups including many wedding groups for golf. Our calendar is full for large shotgun type events. We plan to offer our first shotgun event on June 11 for the Battle Mountain Huskies Tournament with a 11:30am start.
- Our PGA PGM Interns have arrived. We believe we have a great group this summer. Mason and Preston are from Campbell University and Hunter and Gabe are from UNLV.

## **SPORTS**

- Most summer sports camps are full with waiting lists.
- Summer adult league registration is going well, with soccer and softball leagues starting the beginning of June and sand volleyball and cornhole starting mid-June.
- We had a representative of MY Laps out to train us on our chip timing system and used it for the first trail run and youth mountain bike race. We are excited to keep learning and add in all the bells and whistles like live results as we get more comfortable
- We have been working very closely with the Vail Valley Foundation in the planning of this summer's Go Pro Mountain Games. The Sports Department will be the specialists for the Après 5K, Rocky Dog 5K, Ebike race, all XC mountain bike races and the Spring Run Off trail run.
- The Eagle River Water and Sanitation District Whitewater races were delayed a week due to low water volume. We have extended the season one week and we had a record turnout for the first race on May 18<sup>th</sup>.
- We had over 200 finishers in the first Dynafit Vail Trail Running Series event, The Boneyard Boogie. The race was a sell out as we were still under COVID restrictions.
- We are working with the Town of Minturn and the Eagle Valley Land Trust about organizing a downriver kayak race on the Eagle River on June 5.
- The Minturn Mini kicked off the summer Town Mountain Bike Series with very good attendance after 3 short track races. We are looking forward to the first full series event with both Adults and Youth on Wednesday, June 26.
- We will have a busy summer on the fields with events. First up is King of the Mountain Volleyball, June 17-20, followed the next 3 days by the Vail Lacrosse Tournament (youth) and then the Vail Lacrosse Shootout from June 26-July 4.

## **GYMNASTICS**

- The Mask-Erade themed Spring Show hosted 52 gymnastics performers on Saturday, May 8<sup>th</sup>. The event was a success while limiting spectators to one per registered gymnast. The event was broken down into two showcases to allow for both gymnasts and parents to be in the facility while maintaining safe protocols.
- The Vail Gymnastics Classic will take place on September 18<sup>th</sup> and 19<sup>th</sup> at Dobson Ice Arena. We are planning this event as normal and will be using two sets of equipment which can accommodate larger numbers. This competition will host level's 3 – 5 and Xcel Bronze and Silver. After a cancelled fall season in 2020 we anticipate great numbers and a successful event.
- Four of our five recreational week-long summer camps are already full with waitlists. In 2020 we filled camps to 30 per week and we have added 10 spaces this season to 40 registrants. We may increase our maximum numbers through the summer depending on spacing and staff.
- We welcomed a new Head Coach, Thomas Katsiadis. Thomas will be adding programs such as Ninja/Parkour, adult gymnastics, and fitness classes for all. We are excited to have Thomas on board and look forward to implementing new programming through 2021.

## **PICKLEBALL**

- The VRD outdoor season is under way at Golden Peak, where pickleball is offered on six dedicated pickleball courts that are now open and staffed seven days a week.
- Court reservations can be made on the hour for play from 10:00 a.m. to 7:00 p.m. every day. So far in May we have had over 1,000 individual total player reservations at Golden Peak.
- Our pickleball staff is available every day to help players set up games, and to run clinics and lessons.
- Skills and drills and round robin sessions have been completely booked on all six courts on Saturday's and Sunday's from 10 a.m. to 12 p.m., as well as on some weekdays based on demand.
- Summer VRD Pickleball Passes are currently on sale and can be purchased online at the VRD website. So far, we have sold 100 new 2020/21 annual passes for the season that began October 1, 2020 and ends September 30, 2021, and 25 summer passes for the 2021 outdoor season that runs from June 1 to September 30.
